

# Terms & Conditions of Entry - "QLD Come Back, Spend Get Reward"

### Agreement to these T&Cs

- 1. Information on how to enter, dates and prize(s) set out in this document form part of the Terms & Conditions of Entry. By entering this promotion, you agree to these Terms & Conditions of Entry.
- 2. To the extent of any inconsistency between these Terms & Conditions of Entry and any other document, implied terms or representation about this promotion, these Terms & Conditions of Entry prevail.

### This promotion

- 3. The promoter of this promotion is Rexel Holdings Australia Pty Limited (ABN 17 081 022 068) of Level 2, Building 1, Riverview Business Park, 3 Richardson Place, North Ryde NSW 2113 (**Rexel**).
- 4. The Promotion Period is from 12.00am AEST on 6 August 2024 until 11.59pm AEST on 31 October 2024.

## Eligibility to enter

- 5 Excluded from participating in this each promotion are:
  - (a) local, state and federal government departments and authorities; and
  - (b) customers who make purchases other than on a trade account or a credit account with a Participating Rexel Branch; and
  - (c) any customers that trade with Rexel on period contracts; and
  - (d) any customers that are purchasing a project volume of goods; and
  - (e) other key account customers (as determined by Rexel in its absolute discretion); and
  - (f) employees (and their immediate family members) of any Rexel company (for this purpose, "immediate family member" means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step- grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin).
- In addition to clause 5 above, Claiming is only open to a customer who meets all of the following criteria (**Eligible Claimant**):

- 9 By written notice to Rexel at any time, an Eligible Claimant may request to opt out of the promotion.

- Rexel may collect personal information to conduct this promotion. Each Eligible Claimant consents to Rexel using any personal information (including names and contact information) held by Rexel to conduct promotion, including consenting to:
  - i.Rexel disclosing such information to third parties (including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities) in relation to this promotion; and
  - ii.Rexel using the information for promotional, marketing, publicity, research and profiling purposes, including sending emails, SMS or text messages to or telephoning the Eligible Claimant.

### How to enter

- Subject to the Reward Conditions (described below), the Eligible Entrant will receive a virtual gift card to the value described below for each order which meets all of the following criteria:
  - (a) the order is placed on a webstore or in branch, Orders Need to be in Stock to qualify for this promotion, being Rexel Electrical, Ideal Electrical or John R. Turk, on your customer trade or credit account; and
  - (b) the order is placed during the Promotion Period (as defined in section 4); and
  - (c) the order includes products to the value of the promotional spend (as defined below).

Where the spend on products is over \$500+gst in August, \$600+gst in September and \$700+gst in October in any one transaction on one invoice, the following virtual gift cards will be provided: Order value is plus GST.

- spend \$500+gst in August in one invoice for items in stock (no backorders) and receive a \$75 virtual gift card or

#### **Reward Conditions**

The maximum value of virtual gift card card(s) that one company/customer/customer account can receive in the one month of the Promotion Period is stated above for each month only.
- 17 The Eligible Entrant will be notified by email using the primary contact email (if any) held for their Rexel group trade or credit account after you have made a qualifying purchase.
  - (a) Virtual gift cards will be emailed to the Primary Contact 7 to 10 days after a qualifying purchase has been made.
- 18 Rexel will not accept the return of, or refund the price of, any goods purchased, other than where required in accordance with consumer law.
- Tax implications may arise for the Eligible Entrant or their representative from receipt of a virtual gift card, and independent financial advice should be received prior to accepting the virtual gift card.
- If the virtual gift card is wholly or partly unavailable, Rexel may, in its absolute discretion, substitute all or part of it with a benefit to equal or greater value, but it is not obliged to do so.
- No virtual gift card is transferable or able to be swapped for any other item. virtual gift cards are not exchangeable and cannot be taken as cash or an account credit and cannot be taken at another time Each virtual gift card is issued subject to the terms and conditions of its issuer. It is the responsibility of the recipient of the virtual gift card to comply with those terms and conditions. If the virtual gift card is not collected or redeemed within the time specified, then Rexel may treat it as abandoned and forfeited and may dispose of it as Rexel decides in its absolute discretion. By entering the promotion, the recipient agrees that it will not have any claim or rights against Rexel or any of its associates in relation to the virtual gift card.

- Rexel reserves the right, at any time, to verify the validity of claims and claimants (including a claimant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any Eligible Claimant who Rexel has reason to believe has either breached any of these Terms & Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion.
